

**PARTICIPANT & VOLUNTEER'S AGREEMENT AND RELEASE FOR LIABILITY**

1.) Voluntary Participation: I acknowledge that I have voluntarily agreed to participate in the Beatty VFW John Strozzi Post 12108(hereafter Beatty VFW) sponsored *Beatty VFW Bullfrog historical Mining District Poker Run Event held on October 12, 2019 in Beatty, Nevada* and all activities, events or programs. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless Beatty VFW, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used for the project, activity, event or program, to the fullest extent permitted by law.

This is to certify that I as parent or guardian with legal responsibility for this participant(s), do consent and agree to their release as provided above of all the Releasees, and, for myself, my child and our heirs, assigns, and next of kin, I release and agree to indemnify and hold harmless the Releasees, from any and all liabilities incident to my minor child's involvement or participation in these projects, activities, events or programs as provided above, even if arising from the negligence of the Releasees, to the fullest extent permitted by law.
